(NF1)-associated peripheral nerve sheath tumors (neurofibromas and malignant peripheral nerve sheath tumors (MPNSTs)). My laboratory's work in these fields is currently supported by four NIH grants. I also work directly with oncologists, surgeons, pathologists, basic researchers, and biorepository staff to effectively collect, manage, and utilize clinical sample resources. I serve as the Director of the MUSC Hollings Cancer Center Biorepository & Tissue Analysis Shared Resource and Director of the Carroll A. Campbell, Jr. Neuropathology Laboratory (Brain Bank). In addition, I, in collaboration with the Children's Tumor Foundation, have established a national network that collects and banks tumor and other tissues from patients with NF1, NF2 or schwannomatosis. My biorepository efforts are supported by three additional grants from NIH.


